Dear MS-ACEP,

Thank you to everyone that was able to join our 2021 Annual Meeting. It was great to connect with each of you and share ideas on improving emergency medicine in Mississippi. I wanted to share some updates from the meeting through this newsletter. We were glad that all three of our resident representatives could join us this year. They discussed news from their programs, challenges over the past year and collaborative ideas for the coming year. Drs. Carlton, Bundy and Davis (continuing his term as resident representative) provided us updates from Magnolia Regional Health Center in Corinth where they recently welcomed their second class of residents. Dr. Johns, who is also continuing his term as resident representative, gave us an update from Merit Health Wesley in Hattiesburg. We also welcomed Dr. Keeling as UMMC's resident representative and heard from him and Dr. Sandifer about the Jackson program.

While they, and all our Mississippi EM residents, are excited about learning and practicing emergency medicine, as you all very well know, all our EDs are dealing with boarding. We discussed the challenges that COVID-19 continues to impose on our communities and some guidelines on COVID-19 patient management. Please continue to encourage vaccinations in your community. I would also encourage you to consider starting an ED vaccination program, if you don't already have one, as that is another way we can help our state's public health leaders and our patients. up an ED vaccination program, including an ACEP toolkit, [here](#). We also appreciate the assistance of the Disaster Medical Assistance Team that was recently deployed by HHS to assist with our state's COVID-19 response efforts.

The discussion of residencies and practice led us to our next agenda item, the state of our EM workforce. We briefly discussed the workforce report which was recently published and can be accessed [here](#). As we have discussed before, while there are some unique aspects about rural EM, we are not immune to changes in the EM marketplace as a whole. We heard views from physicians across our state as to what they perceive our challenges are and steps to address them.

Your MS-ACEP Councillors and I also recently met with ACEP leadership to discuss some of the workforce efforts at the national level. Their taskforces are evaluating a few topics at present: length and procedural competencies of residency programs and graduating residents respectively to better understand the education process and supply of EM physicians, ED accreditation and scope of practice expansion. You can find the latest updates [here](#). I would also encourage you to review the [Rural Task Force summary](#) to get a better idea of their suggested actions to the ACEP board.

We plan on forming a committee to evaluate our state-wide workforce issues and coordinate with the National Team. If you would be interested in serving on this committee, please let me or Pat know. We still stand firmly opposed to scope creep and will continue to work with MSMA and ACEP on this. I would also like to recognize one of our resident representatives, Dr. Keeling, for recently introducing Resolution 20 at the MSMA's Annual Sessions: "To Study the Economic Impact of Mid-Level Provider Employment in the United States of America and Mississippi". Great work, Max!

We also discussed our plans to create a chapter specific PR committee. Our primary goals are to engage with our local media and community on important health issues and be a source of reliable medical information. Our councillor, Dr. Kency has graciously agreed to lead this effort. Please let me or Pat know if you would like to serve on this committee as we would like to have physicians from different parts of the state and from different practice settings.

We also heard from our first scholarship recipient, Kelsey Morgan, a 3rd year medical student at UMMC, about her experience at LAC this year. You can read more about her experience below. We are very proud of her for being selected to speak on health equity and representing our chapter and state so well. As some of you may know, she serves as the Southeast Regional Representative for EMRA's medical student council and recently wrote a guide for students applying to residency programs. Please feel free to share this with your students: "[Resources & Guidance for EM-Bound Medical Students – 2022](#)". Great work, Kelsey!

We will also be establishing a committee to evaluate future educational scholarships/stipends for EM residents and medical students interested in EM in partnership with their departments/schools. Our secretary-treasurer, Dr. Barrett will be leading this effort. If you would like to serve on this committee, please let me or Pat know.

In other news, MS-ACEP BoD representatives will be attending the EMerald Coast Chapters' 2021 Candidate Forum later this month. We are proud to support Dr. Costello who is a candidate for Vice-Speaker this year!

I would also like to congratulate Dr. Tarver for being accepted to the ACEP Education Committee and Dr. Keeling for being accepted to the ACEP State Legislative/Regulatory Committee! Great work from our MS-ACEP members!

ACEP's Leadership and Advocacy Conference (LAC)

Sunday's Health Policy Primer was dedicated to the basics of health policy with a variety of topics and speakers. I was selected to give a short talk on Health Equity during the Drop the mic portion of the day. This section included six other talented speakers giving five-minute Ted-Style talks on topics related to health policy and advocacy. The rest of the afternoon included panels and speakers that presented topics such as Health Policy through the COVID19 Lens, NEMPAC, and Clinicians as Politicians Panels.

Monday was dedicated to a Leadership Summit and some Leadership & Advocacy Courses. While each one was very informative, the one that I particularly learned the most from concerned Human Trafficking and the Panel on the EM Workforce report. Dr. Jaime Hope gave a powerful and personal account of a human trafficking case in her ED. She gave a great presentation on how we as physicians in the ED can help identify and protect victims of human trafficking. The other BIG topic of the day was the fact that ACEP initially did not sign the "Joint Statement in Support of COVID-19 Vaccine Mandates for All Workers in Health and Long-Term Care" from Council of Medical Specialty Societies (CMSS). After an outpouring of ER Physicians support for this joint statement, ACEP announced that they signed onto the joint statement.


On Tuesday, we reviewed the issues that we were going to talk to our Senators and Congress members. We studied 2 particular bills and also brought up the upcoming Medicare changes. The bills included: the "Dr. Lorna Breen Health Care Provider Protection Act" (S.610/H.R. 1667) and "Mainstreaming Addiction Treatment (MAT) Act" (H.R. 1384/S. 445). Dr. Lorna Breen was a well-known ER physician who died by suicide in April 2020 during the COVID19 pandemic in New York City. This bill works toward ending the stigma associated with healthcare workers seeking mental healthcare. It also commissions a study on burnout and barriers for healthcare professionals to seek care. Since LAC, the Dr. Lorna Breen Act has been passed by the Senate with a few changes and it is now in the process of being sent to the House! The MAT act seeks to eliminate the x-waiver requirement for ER physicians to be able to write buprenorphine prescriptions while establishing a federal education program on the medication and its use.

Overall, ACEP's LAC was an amazing educational and relationship building experience. I hope to continue to use what I learned and grow my relationships with ACEP and EMRA members.
