Rolling Fork Tornado

On Friday, March 24th, 2023, a tornado cut its path through Rolling Fork, and Sharkey County, Mississippi. The National Weather Service in Jackson estimated top wind speeds of 170 miles per hour from this tornado, which was additionally estimated to be three-quarters of a mile in width. The deadly tornado tore through the area, leaving devastation to be managed by citizens and families. And Emergency physicians. The Mississippi Delta and its surrounding areas had no plea to make: immediately, emergency personnel jumped into action. Emergency physicians, nurses, staff, technicians, transport, and medical students have been and certainly remain affected. And challenged. What used to be a quaint Mississippi town and the county seat of Sharkey County has been virtually scraped from the map. Like the Mississippi Gulf Coast in 2005 for Hurricane Katrina, Rolling Fork and Sharkey County were – and largely remain - unrecognizable. What's not unrecognizable is spirit of resilience from Mississippians. Emergency physicians, and their many collaborators, dove into action. From the Gulf Coast, central Mississippi, the Delta, efforts came. Some hours after this disaster, triage teams were deployed, under the advisement and direction of emergency physicians. In collaboration with many state agencies, to include the Mississippi Department of Health and the Mississippi Emergency Management Agency, emergency physicians used their experience to set up a mobile field hospital, providing care, as immediately as possible, to Rolling Fork and the surrounding communities. These unpredictable and unwanted visitors to Mississippi's Tornado Alley are, unfortunately, certain to return. However, with these challenges will also return a more resilient and experienced disaster preparedness response, at the helm of which will, again, be the efforts of emergency physicians in Mississippi.
