# **Message from the President**

The last several months have been very productive for MS ACEP! HB 849, which would allow independent practice of nurse practitioners and CRNAs, died in Senate Committee in early March. We need to stay vigilant about this issue, as it does seem to reappear each year. Be on the lookout for MS ACEP to make a trek to Jackson to discuss with legislators early in next year's session.

Another important issue is workplace violence. In one week alone, I know of two such incidents in MS. A nurse in Jackson was assaulted at UMMC, and a nurse and a resident in North Mississippi were attacked by a patient in the ED while attempting to treat him. These are just two incidents, but all of us see the verbal and physical abuse on an almost daily basis, which has only increased since the pandemic. According to Mississippi law, this violence should be prosecuted as a felony; however, many of these incidents continue to be only prosecuted as misdemeanors. This is unacceptable. Sen. Cindy Hyde-Smith (R-MS) and Angus King (I-Maine) have introduced a U.S. Senate bill that would establish FEDERAL criminal penalties for assaulting a healthcare worker. I'm sure we'd all agree that this is long overdue. MS ACEP is grateful to Sen. Hyde-Smith for leading the charge on this issue in the Senate and looks forward to seeing meaningful change. We were called heroes early in the pandemic, only to be vilified later. We need the support of our law enforcement, district attorneys, and local and state legislators, and we should be vigilant with hospital administrators to be proactive to prevent these occurrences. We are the ones on the frontlines every day, and we are the ones who suffer loss of work and pay, as well as the emotional toll this takes on our staff. Our EDs should be safe places to work and to heal those who need us the most.

At the January MS ACEP Board meeting, we voted to allot funds for residents to attend ACEP's Leadership & Advocacy Conference in Washington, D.C. President-

Elect Dr. Fred Kency and I, along with Dr. Kallean Kennedy, a PGY2 resident at Magnolia Regional Health Center, trekked all over Capitol Hill to meet with representatives for Congressman Trent Kelly, Congressman Michael Guest, and Sen. Roger Wicker. We were honored to meet with Sen. Cindy Hyde-Smith herself to discuss legislative priorities for ACEP, especially for Mississippi. We spoke with them about the boarding crisis, the detrimental effects of Medicare/Medicaid cuts, and physician reimbursement cuts, and the importance of reinstituting the mental health programs supported by the Lorna Breen Act. It was a very productive and fun trip, and we hope to garner more interest from our young physicians in advocacy. Nothing is going to change unless we start at the top.

Also at LAC, I was asked to part of a panel discussion on scope of practice with Dr. Deborah Fletcher, Louisiana ACEP President, and Dr. Samantha Powell, resident at Medical College of Wisconsin and an EMRA Health Policy fellow. It was an exciting experience, and I was able to discuss our experiences here in Mississippi and the importance of trained EM physicians in rural areas, as well as the challenges we continue to face. It was an honor to represent Mississippi on a national stage.

On July 11, the Mississippi State Medical Association will be hosting a Scope of Practice Summit at Table 100 in Flowood. I plan on attending to see what we can do across specialties to preserve physician practice. According to a recent article in JACEP Open, 20-25% of Mississippi emergency departments are NOT covered by a physician. An ABEM-certified emergency physician is absolutely the gold standard. We need to work with our colleagues to bridge this gap and support a law requiring on-site physician coverage of every Mississippi emergency department. Our patients deserve to have a physician taking care of them, and according to polls, patients trust doctors the most in an emergency. In the last few days, South Carolina has passed a bill to this effect, joining Indiana and Virginia. Our challenge in Mississippi is the sheer number of EDs without a physician. I hope to gain some insight and strategies by speaking with others with a stake in taking care of our emergency patients.

We are excited to welcome our new residents to Mississippi and the ranks of MS ACEP on July 1! Be on the lookout for opportunities for your residents in state and national leadership. I'll give more information once they join us officially!

MS ACEP wants to empower its membership, from the Gulf Coast to the Tennessee line, to become an active part of our team. We want your input and opinions on the challenges we face as emergency physicians working in Mississippi. What can MS ACEP do for you?
